For foals that are leaving Canada, a current negative coggins will accompany each foal as well as a health certificate. If transportation is purchased, the transportation price will also include the costs of border and permit fees needed to cross the border into the U.S.

A deposit of at least half the purchase price must be paid within 3 days of your request to hold the foal. The deposit is non-refundable. **Full payment of the foal must be received before August 18, 2023.**

Transportation fees (if applicable) must also be received before August 18, 2023.

All payments should be made to Charleswood Percherons. Deposits can be made by PayPal, certified checks, bank drafts, any Financial Institution issued money order, US or Canadian wire if the buyer's financial Institute and State will allow wires for purchase of live animals. We can also do etransfer within Canada. NO PERSONAL CHECKS OR POSTAL MONEY ORDERS.

IF FOALS ARE NOT PAID FOR IN FULL BY DESIGNATED DEADLINES, THE FOALS WILL NOT BE COGGINS TESTED FOR TRANSPORTATION, WILL NOT BE TRANSPORTED, AND THE DEPOSIT WILL NOT BE RETURNED.

The foals will leave our farm 100% sound and healthy.

In the event a foal becomes injured or ill during the summer months and is unable to leave our farm, a full refund will be issued to the buyer.

We will use very qualified transporters. We will make sure they will take excellent care of the foals during transport. We anticipate safe foal arrival, however, due to the nature and age of foals and the hazards of road travel, stress, or air impurities and so on, the transporter, and seller cannot be held responsible for accidents or health.
